Title of the Practice :-

To create awareness about Covid 19 Pandemic among masses and help the needy during pandemic.

Objectives of the practice (In 100 words):

Blood Donation

Objective of the Practice

- To sensitize the need of donating blood to the needy in time
- To instill the feeling of helping others to breathe life with their precious donation
- To motivate all students to take a pledge to donate blood at least once in a year
- To impart to them the value of blood donation
- To make all aware of the scientific information about the blood group

Context

In the blood bank, there should be enough amount of blood so that it can be provided to the needy patients as and when required in no time. Keeping this context in mind, the Institution has been organizing blood donation camps to promote the blood donation every year.

The primary importance of voluntary Blood Donation is the availability of the safe, stable and sufficient blood in the blood bank for the needy.

Moreover voluntary Blood Donation fosters love and unity in a nation. This is because donating one's precious blood is an act of love for mankind, a life-saving venture made by humanitarian individuals and it is worthy of emulation.

***** The Practice

'Donate Blood, be a Hero' is the favorite slogan of the Institution to promote the practice of Blood Donation in the Institution in particular and in the society in general. On the occasion of the World Blood Donation Week the Institution organizes Blood Donation Camp every year.

On 22 December 2020 the Institution organized the Blood Donation Camp. The blood bank of District Government Hospital, Bhandara is invited to our college for collecting blood from the donors.

Many people including teachers, students, come forward to donate blood. The students of the Institution are made aware about the benefits of the blood donation, hence the boys and girls shows tremendous zeal and enthusiasm in blood donation. In all 32 students came forward to donate blood.

Along with blood donation, the practice of checking hemoglobin in the blood and counting weight is also exercised. This practice also encourages the students for donating blood. Automatically, the blood donor gets this medical facility free of cost.

All the blood donors are provided a Blood Donation Card, Certificate appreciating his/her noble job. The Institution has its 'Blood Directory' which keeps the records of the blood donors and their contact numbers, blood group, etc.

We witness some constraints in performing the activity of Blood Donation. As per the

directions of physicians, the weight of the blood donor should not be less than 48 kg. So the underweight persons, blood pressure patients, hemoglobin deficient cannot donate blood.

& Evidence of Success

This activity of Blood Donation is highly admired. The Institution has been exercising this practice for years now. Needy patients from the nearby places call the Institution for the requirement of blood and the concerning blood was provided to them when the Institution contact the blood bank immediately.

The Institution has proved to be a medium to spread the movement of Blood Donation in the vicinity of the Institution.

By this practice, in some extent, it has heightened the confidence of students, teaching and non-teaching staff and local persons to break the myths regarding blood donation. It has aroused interest among people for blood donation.
