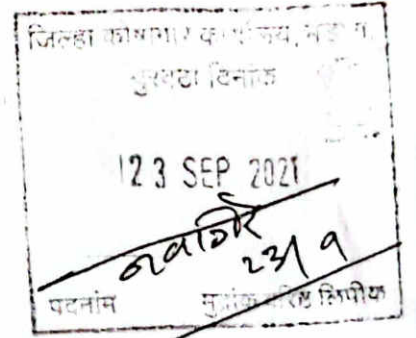

The objective of this memorandum of understanding is to stimulate and Nurture the Scientific temperament in the students and conduct collaborative and mutually beneficial programs under DBT-STAR College scheme of J. M. Patel Arts, Commerce and Science College, Bhandara which serve to upliftment of innovative and creative attitude among the students and staff of both the institutions under the scheme. Thus, **J. M. Patel Arts, Commerce & Science College, Bhandara- 441904 (MS), India** and **Seth Narsingdas Mor College of Arts & Commerce & Smt. G. D. Saraf Science College, Tumsar (MS) India** hereby agree to enter into this agreement for the following purpose.

1. Purpose of Agreement

The purpose of this agreement is to strengthen academic cooperation, deliberations in the fields of Basic Science, Applied Sciences and Biotechnology in the interest of environmental protection and sustainability between the two institutions and to cooperate in their mutual interest for initiating environment protection related activities.

2. Areas of Cooperation

Subject to the availability of resources, infrastructure and approval of the authorities and representatives, both institutions agree to develop the following collaborative activities:

1. Sharing or exchange of scientific and technical information in the field of academics.
2. Joint organization of symposia, conference, seminars, workshops and training programmes
3. Cooperative research on subjects of mutual interest.
4. To strengthen cooperation in the fields of nature protection and sustainability,
5. Provide a basis for the cooperative documentation & development of community-based rural ecotourism and its associated activities in the area that will sustain livelihoods and the local economy.
6. Joint celebrations of World Nature Conservation Day, Ozone Day, Wildlife Week, World Wetland Day, National Science Day, Water Day, World Forestry Day etc.
7. Study tours, exchanges, and temporary assignments of personnel from one institutions to the other;
8. Joint scientific publications; sapling plantation program, environment awareness campaign.
9. Joint EVS projects to demonstrate local environmental burning issue related to management approaches and technologies;
10. Provision of samples, reagents, materials, data, instruments and components for testing, evaluation and other purposes.
11. Other forms of cooperation as may be as an when required by both the institution.

All programs or activities implemented under the terms of this Memorandum of Understanding shall be mutually agreed. Each of the participating institutions shall be fully responsible for the activities carried out under its direction or by its staff, except as otherwise agreed by the institution. Both the institutes will designate one authorized representative each who will develop and coordinate different programs or activities between both these institutions.

Acceptance of Sponsorer: It is the mutual understanding between **J. M. Patel Arts, Commerce & Science College, Bhandara- 441904 (MS), India** and **Seth Narsingdas Mor College of Arts & Commerce & Smt. G. D. Saraf Science College, Tumsar (MS) India** that any schemes under the sponsorship of agencies for Academic & Research upliftment may be incorporated or allowed.

3. Duration and Renewal Of Agreement

This Memorandum of Understanding will become effective immediately after signature by the representatives of **J. M. Patel Arts, Commerce & Science College, Bhandara- 441904 (MS),**

India and Seth Narsingdas Mor College of Arts & Commerce & Smt. G. D. Saraf Science College, Tumsar (MS) India for a period of 3 years and is subject to revision of modification if any by mutual agreement.

4. Amendments

This Memorandum of Understanding may be amended by a written agreement signed by the representatives of both Institutions. In the event of any unforeseen incident during collaborative activities, both Institutions agree to negotiate a mutually acceptable solution. Should any disagreement arise out of the application, interpretation or implementation of this Agreement, the institutions shall endeavor to exercise best efforts to negotiate their differences.

5. Termination of Agreement

This agreement may, at any time during its period of validity, be terminated by either Institution upon prior notice to the other in writing not later than 6 months before termination date, provided that such termination shall not affect the completion of any program or activity underway at the time the notice of termination is given.

6. Approval






